2		purpose of distributing HIP funds in accordance with tribal housing						
3		needs projected in a "Tribal Plan for Use of HIP Funds";						
4	WHEREAS,	The Bureau of Indian Affairs has advised the Papago Tribe of the						
5 6		intent to withhold HIP contracts and recontracts for FY 86 pending						
7		direction from Congress on procedural changes to the HIP program; and						
8	WHEREAS,	The Papago Council agrees that a housing inventory is necessary to						
9		justify and efficiently expend HIP funds but considers the present						
10		method and survey instrument inadequate because it does not accu-						
11		rately reflect the true housing needs of the Papago Tribe; and						
12	WHEREAS,	The survey form will not be recognized as accurate or used in a						
13		subsequent assessment and the preliminary figures obtained as a						
14		result of this survey instrument are submitted under strong protest;

27		nature as they do not accurately reflect the true state of housing						
28		needs of the Papago Tribe, and approves the submission of such						
29		figures only as preliminary effort; and that the Papago Tribe will						
30		conduct a subsequent housing needs assessment and sumbit final data

Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
