

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Base Roll Additions

RES. NO. 35-85

1 WHEREAS, Section 1 (a) of Article II of the Constitution of the Papago Tribe as
2 amended, provides that the Papago Council can make additions and changes
3 to the official census rolls of the Sells and Gila Bend Reservations
4 dated January 1, 1937, and of the San Xavier Reservation dated January
5 1, 1940, subject to the approval of the Secretary of the Interior; and

6 WHEREAS, The Enrollment Committee has determined that the following named
7 persons were members of the Papago Tribe on the date of the respective
8 census rolls but that their names had been inadvertently omitted
9 therefrom, and has recommended that their names be added to the rolls,
10 and

11 WHEREAS, The Papago Council has reviewed the recommendations of the Enrollment
12 Committee and approves thereof.


13 NOW, THEREFORE BE IT RESOLVED by the Papago Council that, subject to the approval
14 of the Secretary of the Interior, the names of the following person be
15 added to the official census rolls of the Sells, Gila Bend or San
16 Xavier Reservation, to wit:


19 BE IT FURTHER RESOLVED that the required approval be secured from the Secretary
20 of the Interior before their names be formally added to such rolls.

21 The foregoing Resolution was duly enacted by the Papago Council on the 07th
22 day of February, 1985, at a meeting at which a quorum was present with a vote
23 of 1,440.0 for; -0- against; -0- not voting; and 03 absent, pursuant to
24 the authority vested in the Papago Council by Article II and Article V, Section
25 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
26 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
27 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
28 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
29 Secretary of the Interior and is effective as of the date of its enactment by
30 the Papago Council.
