22 indicated.


23 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the
24 Papago Tribe reduce this final determination in writing regarding each
25 of the foregoing applications for enrollment in accordance with Section
26 3 (c) of Article III of the Papago Tribal Enrollment Ordinance; give
27 notice of this Council's determination in accordance with Section 4
28 of Article III of the Papago Tribal Enrollment Ordinance; and place
29 the names of each applicant upon the Tribal membership roll in
30 accordance with Article V of the Papago Tribal Enrollment Ordinance.

31 The foregoing Resolution was duly enacted by the Papago Council on the 5th
32 day of June, 1985, at a meeting at which a quorum was present with a vote of
1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the



1 authority vested in the Papago Council by Article II and Article V, Section 2
2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
3 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
4 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
5 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
6 Secretary of the Interior and is effective as of the date of its enactment by
7 the Papago Council.
