WHEREAS,	the Papago Council did by Resolution No. 336-85 authorize the
	appropriate officers of the Papago Tribe to negotiate for the purchase
	of approximately 22.796 acres of land adjoining Florence Village for a
	purchase price of \$40,000.00, conditioned upon approval of such acqui-
	sition and acceptance of the land by the Secretary of the Interior in
	trust and as an addition to and part of the Papago Reservation; and

WHEREAS, the Papago Council has reviewed the draft of a proposed Purchase

Agreement to purchase said land for a purchase price of \$40,000.00,

with a purchase closing date of October 30, 1985; and

WHEREAS, the Gu Achi District Council has appropriated \$20,000.00 of funds in the Gu Achi District's I.I.M. account for the purpose of such purchase which can serve as down payment under the Purchase Agreement, and the Papago Council hereby agrees to appropriate up to \$25,000.00 of tribal funds in its FY 1986 budget to cover the balance of the purchase price.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby approve execution of a Purchase Agreement, substantially in form and substance of the attached Purchase Agreement, for the purchase of approximately 22.796 acres of land adjoining Florence Village for a purchase price of \$40,000.00, and does hereby authorize and direct the Chairman or other appropriate officers of the Papago Tribe to execute such agreement and any other instruments or documents necessary or incidental to the purchase of such land on behalf of the Papago Tribe.

BE IT FURTHER RESOLVED that the Treasurer of the Papago Tribe is authorized and directed to pay into escrow, as down payment as provided in such agreement, \$20,000.00 appropriated for such purpose by the Gu Achi District Council from its I.I.M. account, and is further authorized and directed to pay the balance into escrow, as provided in such

NO. 367-85 (Authorizing Purchase of Additional Lands for Florence Village) Page Two (2) agreement as soon as the necessary tribal funds have been appropriated by the Papago Council pursuant to the 1986 FY budget of the Papago The foregoing Resolution was duly enacted by the Papago Council on the 6th day of June, 1985, at a meeting at which a quorum was present with a vote of 1640.0 for; -0- against; -0- not voting; and 0 absent, pursuant to the authority vested in the Papago Council by Section 2 (a), and Section 3 (a) and (h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
