

1 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the
2 Papago Tribe reduce this final determination in writing regarding each
3 of the foregoing applications for enrollment in accordance with Section
4 3 (c) of Article III of the Papago Tribal Enrollment Ordinance; give
5 notice of this Council's determination in accordance with Section 4 of
6 Article III of the Papago Tribal Enrollment Ordinance; and place the
7 names of each applicant upon the Tribal membership roll in accordance
8 with Article V of the Papago Tribal Enrollment Ordinance.

9 The foregoing Resolution was duly enacted by the Papago Council on the 07th
10 day of February, 1985, at a meeting at which a quorum was present with a vote
11 of 1,333.0 for; -0- against; 107.0 not voting; and -0- absent, pursuant
12 to the authority vested in the Papago Council by Article II and Article V,
13 Section 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as
14 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the
15 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
16 of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by
17 the Secretary of the Interior and is effective as of the date of its enactment
18 by the Papago Council.
