

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Road Contract Project)

RES. NO. 373-85

1 WHEREAS, in consultation with the Secretary of Interior the Secretary of
2 Transportation has allocated the sums authorized to be appropriated for
3 the Fiscal Year 1985 for construction and improvements of Indian
4 Reservation roads; and

5
6 WHEREAS, The sum of five million dollars (\$5,000,000.00), more or less has been
7 allocated for the construction and or improvements of certain roads on
8 the Papago Reservation; and

9 WHEREAS, The exact description including the plans and specifications of this
10 road project are provided for in the BIA's Solicitation No. H54-R-5-6;
11 and

12 WHEREAS, the provisions of 23 U.S.C. Chapter 2 Section 204(B) authorizes the
13 Secretary of Interior to enter into government to government
14 construction contracts with a state, civil subdivision thereof or
15 Indian Tribes for construction and improvements of roads under the
16 Federal Land Highway Program; and

18 WHEREAS, The Secretary of Interior is in the process of entering into
19 construction contracts with parties other than Indian tribes for the
20 construction and improvements of roads on Indian Reservations

21 WHEREAS, it would be in the best interest of the Papago Tribe if a contract
22 between the Papago Tribe and the Secretary of Interior was entered into
23 for the construction and/or improvement of that certain road project
24 described in BIA's Solicitation No. H54-R-5-6.

26 NOW, THEREFORE BE IT RESOLVED that the Papago Tribal Council does hereby
27 request that the Secretary of Interior, pursuant to 23 U.S.C.
28 Chapter 2, Section 204(B) enter into a construction contract and
29 such other contracts as maybe appropriate in connection thereto with
30 the Papago Tribe for the construction and or improvement of other
31 certain roads on the Papago Reservation as described in the BIA's

1 Solicitation No. H54-R-5-6 and for the purpose for said contract the
2 tribe does hereby adopt by reference the construction plans and
3 specifications and such other documents, data, or other materials that
4 maybe necessary or appropriate as published in said Solicitation.


6 BE IT FURTHER RESOLVED that the Chairman and other necessary Tribal Officials
7 are hereby authorized to prepare, execute and submit to the proper
8 Federal agencies applications, documents, data, contracts, plans and
9 contracts necessary to initiate and finalize this road construction
10 contract, to advertise for bids and to award a contract or contracts
11 for such road construction and or improvements and to monitor and
12 supervise said contract or contracts.

14 BE IT FURTHER RESOLVED that due to the fact that the Papago Tribe will be the
15 contractor of this road construction contract, the Transaction
16 Privilege Tax, Ordinance No. 03-81 will be inapplicable as to this
17 project.

18 The foregoing Resolution was duly enacted by the Papago Council on the 6th
19 day of June, 1985, at a meeting at which a quorum was present with a vote of
20 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the
21 authority vested in the Papago Council by Section 2 (a), (d) and (f) of Article
22 V of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
23 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
Secretary of the Interior and is effective as of the date of its enactment by
the Papago Council.
