

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Acceptance of the Papago Children's Home  
P. L. 93-638 FY 1986 Budget Contract)

RES. NO. 377-85

1 WHEREAS, the Papago Tribe of Arizona is presently operating the Papago  
2 Children's Home under FY 1985 P. L. 93-638 contract with the Bureau of  
3 Indian Affairs; and

4 WHEREAS, such Tribal operations have been successful and beneficial to the  
5 Papago Tribe and its people; and

6 WHEREAS, 25 CFR Sec 271.20 of the Federal Regulations requires that all  
7 proposals to recontract under P. L. 93-638 be submitted to the Tribal  
8 Council for approval at least 120 days prior to the contract termina-  
9 tion; and

10 WHEREAS, the Papago tribal Council does desire to recontract for provision of  
11 these services during FY 1986; and

12 WHEREAS, The Papago Tribal Council has reviewed and approved the Papago  
13 Children's Home contract.

14 NOW, THEREFORE, BE IT RESOLVED, by the Papago Council that it does authorize  
15 and request the Bureau of Indian Affairs to contract with the Papago  
16 Tribe under P. L. 93-638 regulations and procedures for the provision  
17 of services titled Papago Children's Home.

18 BE IT FURTHER RESOLVED that the term of this contract shall commence on October  
19 01, 1985 and end September 30, 1986.


20 BE IT FURTHER RESOLVED that the Papago Tribe will not fund or operate programs  
21 from which contracts are requested herewith which have not been  
22 negotiated and executed by the Bureau of Indian Affairs prior to the  
23 start of the funding year.

24 BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Jr., Vice-  
25 Chairman or Rosita Ruiz, Treasurer, of the Papago Council is hereby  
26 authorized to negotiate and execute these contracts and any amendments  
27 thereto for the duration of the contracts.

28 The foregoing Resolution was duly enacted by the Papago Council on the 7th  
29 day of June, 1985, at a meeting at which a quorum was present with a vote of

1 1640.0 for; -0- against; -0- not voting; and 2 absent, pursuant to the  
2 authority vested in the Papago Council by Section 2 (a), (d) and (m) of Article  
3 V of the Constitution and By-laws of the Papago Tribe of Arizona as amended,  
4 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
5 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June  
6 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the  
7 Secretary of the Interior and is effective as of the date of its enactment by  
8 the Papago Council.
