

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
Acceptance of the Johnson O'Malley  
P.L. 93-638 FY 1986 Budget Contract

RES. NO. 383-85

1 WHEREAS, the Papago Tribe of Arizona is presently operating the Johnson  
2 O'Malley under FY 1985 P. L. 93-638 contract with the Bureau of Indian  
3 Affairs; and

4 WHEREAS, such Tribal operation have been successful and beneficial to the  
5 Papago Tribe and its people; and

6 WHEREAS, 25 CFR Sec. 271.20 of the Federal Regulations requires that all  
7 proposals to recontract under P. L. 93-638 be submitted to the Tribal  
8 Council for approval at least 120 days prior to the contract  
9 termination; and

10 WHEREAS, The Papago Tribal Council does desire to recontract for provisions of  
11 these services during FY 1985; and

12 WHEREAS, The Papago Tribal Council has reviewed and approved the Johnson  
13 O'Malley contract.

14 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does authorize  
15 and request the Bureau of Indian Affairs to contract with the  
16 Papago Tribe under P. L. 93-638 regulations and procedures for the  
17 provision of services titled Johnson O'Malley.

18 BE IT FURTHER RESOLVED that the Papago Council does hereby authorize the  
19 Papago Tribe to enter into a multi-year contract with the Bureau of  
20 Indian Affairs pursuant to 25 CFR 271.52. The contract term shall  
21 commence on October 1, 1985 and end on September 30, 1988.

22 BE IT FURTHER RESOLVED that the Papago Tribe will not fund or operate programs  
23 from which contracts are requested herewith which have not been  
24 negotiated and executed by the Bureau of Indian Affairs prior to  
25 the start of the funding year.

26 BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Jr., Vice  
27 Chairman or Rosita Ruiz, Treasurer, of the Papago Council is hereby  
28 authorized to negotiate and execute these contracts and any  
29 amendment thereto for the duration of the contracts.

1 The foregoing Resolution was duly enacted by the Papago Council on the 7th  
2 day of June, 1985, at a meeting at which a quorum was present with a vote of  
3 1640.0 for; -0- against; -0- not voting; and 2 absent, pursuant to the  
4 authority vested in the Papago Council by Section 2 (a), (d) and (m) of Article  
5 V of the Constitution and By-laws of the Papago Tribe of Arizona as amended,  
6 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
7 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June  
8 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the  
9 Secretary of the Interior and is effective as of the date of its enactment by  
10 the Papago Council.
