WHEREAS, the Papago Tribe of Arizona is presently operating the following program under a continuation of FY '85 P. L. 93-638 service contract with the Public Health, Indian Health Service;

Management of Health Services

- WHEREAS, such Tribal operations have been successful and beneficial to the Papago Tribe and its people; and
- WHEREAS, 25 CFR Sec 271.20 requires that all proposals to recontract under P. L. 93-638 be submitted to the Tribal Council for approval at least 120 days prior to the contract termination; and
- WHEREAS, The Papago Tribal Council does desire to recontract for provisions of these services during FY 1986
- NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that it does authorize and request the Public Health Indian Health Service to contract with the Papago Tribe under P. L. 93-638 regulations and procedures for the provision of services titled:

Management of Health Services

- BE IT FURTHER RESOLVED that the duration of this contract shall be from October 1, 1985, through September 30, 1986, unless extended by mutual agreement of both parties.
- BE IT FURTHER RESOLVED in the event that this contract does not become effective on October 1, 1985, through September 30, 1986, continuation of this program will be based on an extension of the existing 1985 contract until such time that the 1986 contract becomes effective.
- BE IT FURTHER RESOLVED that the Papago Tribe will not fund or operate a program for which a contract is requested herewith and that has not been negotiated and executed by the Indian Health Service prior to the start of the funding year.

NO. 386-85 (Request to Recontract under P.L. 93-638/Indian Health Service) Page Two (2) BE IT FURTHER RESOLVED that Josiah Moore, Chairman, or in his absence, Francisco Jose, Vice Chairman or Rosita N. Ruiz, Treasurer, is hereby authorized to negotiate and execute this contract and any amendments thereto for the duration of the contract. The foregoing Resolution was duly enacted by the Papago Council on the 7th day of June, 1985, at a meeting at which a quorum was present with a vote of 1640.0 for; -0- against; -0- not voting; and 4- absent, pursuant to the authority vested in the Papago Council by Section 2 (a), (d) and (m) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
