

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
Request to Recontract under P. L. 93-638/Indian Health Service

RES. NO. 386-85

1 WHEREAS, the Papago Tribe of Arizona is presently operating the following  
2 program under a continuation of FY '85 P. L. 93-638 service contract  
3 with the Public Health, Indian Health Service;

4 Management of Health Services

5  
6 WHEREAS, such Tribal operations have been successful and beneficial to the  
7 Papago Tribe and its people; and

8 WHEREAS, 25 CFR Sec 271.20 requires that all proposals to recontract under  
9 P. L. 93-638 be submitted to the Tribal Council for approval at  
10 least 120 days prior to the contract termination; and

11 WHEREAS, The Papago Tribal Council does desire to recontract for provisions of  
12 these services during FY 1986

13  
14 NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that it does  
15 authorize and request the Public Health Indian Health Service to  
16 contract with the Papago Tribe under P. L. 93-638 regulations and  
17 procedures for the provision of services titled:

18 Management of Health Services

19 BE IT FURTHER RESOLVED that the duration of this contract shall be from  
20 October 1, 1985, through September 30, 1986, unless extended by  
21 mutual agreement of both parties.



23 BE IT FURTHER RESOLVED in the event that this contract does not become  
24 effective on October 1, 1985, through September 30, 1986,  
25 continuation of this program will be based on an extension of the  
26 existing 1985 contract until such time that the 1986 contract  
27 becomes effective.

28 BE IT FURTHER RESOLVED that the Papago Tribe will not fund or operate a  
29 program for which a contract is requested herewith and that has not  
30 been negotiated and executed by the Indian Health Service prior to  
31 the start of the funding year.

1 BE IT FURTHER RESOLVED that Josiah Moore, Chairman, or in his absence,  
2 Francisco Jose, Vice Chairman or Rosita N. Ruiz, Treasurer, is  
3 hereby authorized to negotiate and execute this contract and any  
4 amendments thereto for the duration of the contract.

6 The foregoing Resolution was duly enacted by the Papago Council on the 7th  
7 day of June, 1985, at a meeting at which a quorum was present with a vote of  
8 1640.0 for; -0- against; -0- not voting; and 4 absent, pursuant to the  
9 authority vested in the Papago Council by Section 2 (a), (d) and (m) of Article  
10 V of the Constitution and By-laws of the Papago Tribe of Arizona as amended,  
11 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
12 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June  
13 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the  
14 Secretary of the Interior and is effective as of the date of its enactment by  
15 the Papago Council.
