15	authority vested in the Papago Council by Article II and Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
16	amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
17	of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by
18	the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
