

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Referring Enrollment Application of JEFFERY LUCAS)
(Back to Enrollment Committee)

RES. NO. 430-85

1 WHEREAS, The Enrollment Committee has recommended to the Papago Council that
2 the enrollment application which has been filed for or on behalf of
3 JEFFERY LUCAS ("applicant") be denied because the applicant failed
4 to establish the necessary membership requirements; and

5 WHEREAS, The Papago Council has reviewed the evidence presented on the
6 applicant's behalf and believes that the applicant should be given a
7 further opportunity to establish necessary membership requirements.


9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby refer
10 the application of JEFFERY LUCAS back to the Enrollment Committee for
11 further consideration and action in accordance with the provisions
12 of the Papago Enrollment Ordinance.

13 The foregoing Resolution was duly enacted by the Papago Council on the 1st
14 day of July, 1985, at a meeting at which a quorum was present with a vote of
15 1,496.5 for; 85.0 against; 58.5 not voting; and 03 absent, pursuant to the
16 authority vested in the Papago Council by Article II and Section 2 (f) of
17 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
18 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the
19 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by
the Secretary of the Interior and is effective as of the date of its enactment
by the Papago Council.
