WHEREAS, The Enrollment Committee has recommended to the Papago Council that the enrollment application which has been filed for or on behalf of FIDEL MACIAS JR. ("applicant") be denied because the applicant failed to establish the necessary membership requirements; and WHEREAS, The Papago Council has reviewed the evidence presented on the applicant's behalf and believes that the applicant should be given a further opportunity to establish necessary membership requirements.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby refer the application of FIDEL MACIAS JR. back to the Enrollment Committee for further consideration and action in accordance with the provisions of the Papago Enrollment Ordinance.

The foregoing Resolution was duly enacted by the Papago Council on the 2nd day of July, 1985, at a meeting at which a quorum was present with a vote of 1,640.0 for; -0- against; -0- not voting; and 05 absent, pursuant to the authority vested in the Papago Council by Article II and Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of Act the of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
