(Referring Enrollment Application of CHRISTINA PRIETO)
((MACIAS) Back to Enrollment Committee)

1 WHEREAS, The Enrollment Committee has recommended to the Papago Council that
2 the enrollment application which has been filed for or on behalf of
3 CHRISTINA PRIETO (MACIAS) ("applicant") be denied because the
4 applicant failed to establish the necessary membership
5 requirements; and

7 WHEREAS, The Papago Council has reviewed the evidence presented on the
8 applicant's behalf and believes that the applicant should be given a
9 further opportunity to establish necessary membership requirements.


10 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby refer
11 the application of CHRISTINA PRIETO (MACIAS) back to the Enrollment
12 Committee for further consideration and action accordance with the
13 provisions of the Papago Enrollment Ordinance.

15 The foregoing Resolution was duly enacted by the Papago Council on the 2nd day
16 of July, 1985, at a meeting at which a quorum was present with a vote of
17 1,640.0 for; -0- against; -0- not voting; and 05 absent, pursuant to the
18 authority vested in the Papago Council by Article II and Section 2 (f) of
19 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
20 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of Act
of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review
by the Secretary of the Interior and is effective as of the date of its
enactment by the Papago Council.
