
1 WHEREAS, The Enrollment Committee has recommended to the Papago Council that  
2 the enrollment application which has been filed for or on behalf of  
3 LISA MARIA PRIETO ("applicant") be denied because the applicant  
4 failed establish the necessary membership requirements; and

6 WHEREAS, The Papago Council has reviewed the evidence presented on the  
7 applicant's behalf and believes that the applicant should be given a  
8 further opportunity to establish necessary membership requirements.

9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby refer  
10 the application of LISA MARIA PRIETO back to the Enrollment  
11 Committee for further consideration and action accordance with the  
12 provisions of the Papago Enrollment Ordinance.

14 The foregoing Resolution was duly enacted by the Papago Council on the 2nd day  
15 of July, 1985, at a meeting at which a quorum was present with a vote of  
16 1,640.0 for; -0- against; -0- not voting; and 05 absent, pursuant to the  
17 authority vested in the Papago Council by Article II and Section 2 (f) of  
18 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
19 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of Act  
of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review  
by the Secretary of the Interior and is effective as of the date of its  
enactment by the Papago Council.
