RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Tabling consideration of proposed Land)
(Planning and Zoning Ordinance)

RES. NO. 50-85

WHEREAS, The Papago Council has reviewed and called for District review and discussion of a proposed Land Planning and Zoning Ordinance which would delegate, to such of the District Councils which decide to avail themselves thereof, the power and authority to adopt, amend and enforce codes and regulations for land use planning, regulating development and zoning within their respective districts; and

WHEREAS, The Papago Council has determined that the purpose and scope of the ordinance is such that it would be of use and benefit only to the San Xavier District.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby table further consideration of the ordinance and does hereby authorize and direct the San Xavier District Council, after review and public hearings, to prepare and submit an alternative ordinance for review by the Papago Council which would grant authority and power to the San Xavier District Council to adopt, amend and enforce codes and regulations for land use planning and zoning within the San Xavier Reservation.

The foregoing Resolution was duly enacted by the Papago Council on the 6th day of March, 1985, at a meeting at which a quorum was present with a vote of 1,003.5 for; 132.5 against; 304.0 not voting; -0- absent, pursuant to the authority vested in the Papago Council by Section 2 (e) and (f) of Article V of the Constitution and By-laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
