
WHEREAS, The Gu Achi District Council did on January 16, 1985 pass a resolution approving a FY 85 budget totaling \$17,556.73 of Revenue Sharing Funds allocated to the Gu Achi District; and

WHEREAS, The Papago Council has reviewed the proposed budget a copy of which is attached hereto, and has determined that it covers expenditures of Revenue Sharing Funds recommended at the public hearings held for such purposes.

NOW, THEREFORE BE IT RESOLVED by the Papago Council that it does hereby approve the attached FY 85 Revenue Sharing Budget and does hereby authorize expenditures in accordance therewith.

The foregoing Resolution was duly enacted by the Papago Council on the 6th day of March, 1985, at a meeting at which a quorum was present with a vote of 1,440.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the authority vested in the Papago Council by Section 2 (a) and (d) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
