14	of July, 1985, at a meeting at which a quorum was present with a vote of 1497.0 for; 84.5 against; 58.5 not voting; and 02 absent, pursuant to the authority
15	vested in the Papago Council by Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago
16	Tribe on December 12, 1936, and approved by the Secretary of the Interior on
17 18	January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interio
10	and is effective as of the date of its enactment by the Papago Council.
