


RESOLUTION OF THE PAPAGO COUNCIL
(Supporting Gu Achi District Resolution)

RES. NO. 535-85

1 WHEREAS, The Gu Achi District Council did on May 29, 1985, by
2 Resolution No. 685-01, a copy of which is attached
3 hereto, ask the Papago Council and the tribal Law
4 Enforcement agency to help enforce tribal liquor and
5 substance abuse laws and to prosecute violators within
6 Gu Achi District boundaries, and did further ask that
7 maximum penalties be imposed on such violators; and
8 WHEREAS, The Papago Council has reviewed the request and concurs
9 therein
10 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does
11 hereby support the action of the Gu Achi District
12 Council as memorialized in the Resolution No. 685-01,
13 and does hereby ask that Tribal Administration report
14 back to the Papago Council within six months concerning
15 the implementation of this resolution by law enforce-
16 ment, court and other appropriate officials and officers
17 of the Papago Tribe.

18 The foregoing Resolution was duly enacted by the Papago Council
19 on the 10th day of July, 1985, at a meeting at which a
20 quorum was present with a vote of 1,502.0 for; -0- against;
21 138.0 not voting; and -0- absent, pursuant to the authority
22 vested in the Council by Section 2(e), (f) and (h) of Article V
23 of the Constitution and By-laws of the Papago Tribe as amended,
24 ratified by the Papago Tribe on December 12, 1936, and approved
25 by the Secretary of the Interior on January 6, 1937, pursuant
26 to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
27 Resolution is not subject to review by the Secretary of Interior
28 and is effective as of the date of its enactment by the Papago
29 Council.
