1 federal regulations require that each recipient govern-2 ment which expends federal revenue sharing entitlement funds shall, prior to the revenue sharing budget hear-3 4 ing and enactment of the revenue sharing budget, have 5 at least one public hearing on the possible uses of such funds, at which hearing all citizens of the recip-6 7 ient government shall have the opportunity to provide 8 such government with written and/or oral comments and suggestions as to possible uses; and 9 10 WHEREAS, the Papago Council finds that such public hearing is 11 best conducted before the Papago Council in Sells. 12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it 13 conduct a public hearing at the Council chambers in Sells on the possible uses of entitlement funds and 14

that notice of such hearing be given in accordance with the provisions of 31 C.F.R. §51.13.

The foregoing Resolution was duly rejected by the Papago Council on the 10th day of July , 1985, at a meeting at which a quorum was present with a vote of 680.0 for; 897.0 against; 63.0 not voting; and -0- absent, pursuant to the authority

vested in the Council by Section 2(a)(e) and (f) of Article V of the Constitution and By-laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its rejection by the Papago Council.
