

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Sif Oidak District Budget FY 1986)

RES. NO. 549-85

1 WHEREAS, The Sif Oidak District Council has considered and reviewed its  
2 proposed activities for FY 86 and prepared a budget to cover  
3 anticipated cost and expenses; and

4 WHEREAS, The Sif Oidak District Council did by Resolution No. 13-85 approve the  
5 proposed budget for FY 86 in the amount of \$192,347.92 said budget  
6 period to begin on August 01, 1985 and end on July 31, 1986.

7  
8 WHEREAS, The Sif Oidak District maintains an account at the First Interstate  
9 Bank, Casa Grande and has authorized the following officers of the  
10 Council to have authority to sign checks on the Account, the Chairman,  
11 Vice-Chairman and Secretary.

12 WHEREAS, The Sif Oidak District Council has sufficient funds in its IIM Account  
13 to cover the proposed budget; and

14  
15 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
16 approve the attached FY 86 budget of the Sif Oidak District and  
17 authorizes expenditures in accordance therewith;


18 BE IT FURTHER RESOLVED by the Papago Council that it does hereby authorizes  
19 the Sif Oidak District to maintain a seperate District Account with  
20 the First Interstate Bank of Arizona, Casa Grande, Arizona, which  
21 shall provide that any of the following officers of the District  
22 Coucil, i.e., the Chairman, Vice-Chairman and Secretary.

23 BE IT FURTHER RESOLVED that the Papago Council does hereby give authority to  
24 the Sif Oidak District to transfer funds on deposit in the District's  
25 IIM Account into an account with the First Interstate Bank of Arizona  
26 in Casa Grande, an amount not to exceed one half of the total District  
27 budget, \$96,173.96 and remainder to be transferred when needed to meet  
28 the District's budgeted expenses.

29 The foregoing Resolution was duly enacted by the Papago Council on the 11th  
30 day of July, 1985, at a meeting at which a quorum was present with a vote of  
31 1,640.0 for; -0- against; -0- not voting; and 03 absent, pursuant to the  
32 authority vested in the Papago Council by Section 2 (f) and Section 3 (a) of  
Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of  
the date of its approval by the Superintendent of the Papago Agency and is  
subject to review by the Secretary of the Interior.


