

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Base Roll Additions)

RES. NO. 57-85

1 WHEREAS, Section 1 (a) of Article II of the Constitution of the Papago Tribe
2 as amended, provides that the Papago Council can made additions and
3 changes to the official census rolls of the Sells and Gila Bend
4 Reservations dated January 1, 1937, and of the San Xavier Reservation
5 dated January 1, 1940, subject to the approval of the Secretary of
6 the Interior; and

7 WHEREAS, The Enrollment Committee has determined that the following named
8 persons were members of the Papago Tribe on the date of the respective
9 census rolls but that their names had been inadvertently omitted
10 therefrom, and has recommended that their names be added to the rolls;
11 and

12 WHEREAS, The Papago Council has reviewed the recommendations of the Enrollment
13 Committee and approves thereof.


14 NOW, THEREFORE BE IT RESOLVED by the Papago Council that, subject to the
15 approval of the Secretary of the Interior, the names of the following
16 persons be added to the official census rolls of the Sells, Gila Bend
17 or San Xavier Reservations, to wit:

25 BE IT FURTHER RESOLVED that the required approval be secured from the Secretary
26 of the Interior before their names be formally added to such rolls.

27 The foregoing Resolution was duly enacted by the Papago Council on the 07th
28 day of March, 1985, at a meeting at which a quorum was present with a vote of
29 1,386.5 for; -0- against; 53.5 not voting; and -0- absent, pursuant to the
30 authority vested in the Papago Council by Section 1 (a) of Article II and
31 Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe
32 of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not
subject to review by the Secretary of the Interior and is effective as of the
date of its enactment by the Papago Council.
