KEITH ("applicant") be denied because the applicant 4 failed establish the necessary membership requirements; and 5 WHEREAS, The Papago Council has reviewed the evidence presented on the 6 applicant's behalf and believes that the applicant should be given a 7 8 further opportunity to establish necessary membership requirements. NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby refer 10 the application of GLORIA J. KEITH back to the Enrollment 11

Committee for further consideration and action accordance with the provisions of the Papago Enrollment Ordinance.

The foregoing Resolution was duly enacted by the Papago Council on the 12th day of July, 1985, at a meeting at which a quorum was present with a vote of 1,529.0 for; -0- against; 111.0 not voting; and 01 absent, pursuant to the authority vested in the Papago Council by Article II and Section 2 (f) of 16||Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of Act the of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
