

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Water Commissioner Budget)

RES. NO. 60-85

1 WHEREAS, the Papago Tribal Council, by Resolution No. 18-80, did appoint Water  
2 Commissioners for the purpose of gathering information, studying, hold-  
3 ing public hearings in the affected Districts and making recommenda-  
4 tions to the Tribal Council in regard to all water litigation, water  
5 rights violations and all other water problems of the Papago Tribe;  
6 and

7 WHEREAS, there is an urgent need for the continued services of the Water  
8 Commissioners and the establishment of a budget for the fiscal year  
9 beginning October 1, 1984, and ending September 30, 1985; and

10 WHEREAS, the Water Commissioners have prepared a budget and justification  
11 therefore for this period of time, a copy of which is attached hereto  
12 and made a part hereof; and


13 WHEREAS, it has been determined that the income accruing to the Trust fund  
14 established under Section 309 of P.L. 97-293 may be used as a source  
15 of funding the Water Commissioner Budget; and

16 WHEREAS, it would be in the best interest of the Papago Tribe if the services  
17 of the Water Commissioners are continued and their proposed budget is  
18 approved by the Council.

19 NOW, THEREFORE BE IT RESOLVED that the Tribal Council approves the attached  
20 budget for the Water Commissioners and directs that Papago P.L. 97-293  
21 Trust-Income accounts established and maintained pursuant to Ordinance  
22 No. 03-83 be used to fund said budget.

23 The foregoing Resolution was duly enacted by the Papago Council on the 7th  
24 day of March, 1985, at a meeting at which a quorum was present with a vote of  
25 910.0 for; 253.5 against; 276.0 not voting; and 0 absent, pursuant to the  
26 authority vested in the Council by Section 2(a), (d), (c), (h) and Section 3(a)  
27 of Article V of the Constitution and By-laws of the Papago Tribe as amended,  
28 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June  
18, 1934, (48 Stat. 984). Said Resolution is effective as of the date of its  
approval by the Superintendent of the Papago Agency and is subject to review  
by the Secretary of the Interior.
