2		Act of 1982" provides in Section 303 (b) (1) "In order to encourage

5		out a study to determine the availability and suitability of water

9	WHEREAS,	Section 309 (b) of Title III of the Act states "The authorized govern-
10		ing body of the Papago Tribe, as trustee for such Tribe, may only spend
11		each year the interest and dividends accruing on the sum held and in-
12		vested pursuant to subsection (a). Such amount may only be used by
13		the Papago Tribe for the subjugation of land, development of water
14		resources, and the construction, operation, maintenance and replacement
15		of related facilities on the Papago Reservation which are not the
16		obligation of the United States under this or any other Act of
17		Congress."; and
18	WHEREAS,	Resolution No. 19-85 of the Papago Tribe which was duly enacted by the
19		Papago Tribal Council on January 22, 1985, established a Water Manage-
20		ment Committee to assist the Tribe in fulfilling the purposes and
21		intent of Section 303 (b) (1) of Title III of the Act; and
22	WHEREAS,	it is necessary that the Tribal Council establish a budget for the
23		Water Management Committee for the remainder of the fiscal year (March
24		1, 1985 to September 30, 1985); and
25	WHEREAS,	the Tribal Water Commissioners have prepared a proposed Water Manage-
26		ment Committee budget for the remainder of this fiscal year, a copy
27		of which is attached hereto and made a part hereof, and
28	WHEREAS,	it has been determined that the income accruing to the Trust fund
