1 WHEREAS, The Sif Oidak District Council previously passed a resolution 2 restricting new mining within the district; and 3 WHEREAS, The Sif Oidak District is willing to consider a gold mine exploration 4 and development proposal and has presented to the Papago Council a 5 modification of such mining restrictions; and 6 WHEREAS, The Papago Council believes that the 10% increase of mining income to 7 be allocated to the Sif Oidak District is a matter that should be 8 9 discussed by all districts affected. NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the Sif Oidak's 11 Modification of Mining Restrictions, Resolution No. 9-85 is hereby 12 returned to the individual districts for comment and input. 13 The foregoing Resolution was duly enacted by the Papago Council on the 7th day |14| of August, 1985, at a meeting at which a quorum was present with a vote of 1442.5 for; -0- against; 197.5 not voting; and 1 absent, pursuant to the authority vested in the Papago Council by Section 2 (f) and (h) of Article V of 16 the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the 17 Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
