1	WHEREAS,	Under the provisions of P.L. 97-293, 96 Stat. 1274, the Schuk Toak
2		District will receive as soon as possible, but not later than October
3		12, 1992, sixteen thousand (16,000) acre feet of imported water
4		delivered through the Central Arizona Project aqueduct; and
5	WHEREAS,	To utilize 16,000 acre feet of imported water, it is necessary that
7		the Schuk Toak District and the Papago Tribal Council select
8		approximately 4,000 acres of land for an irrigation project; and
9	WHEREAS.	To develop an agricultural area of this size it is mandatory that the
10	,	land to be serviced by the 16,000 acre feet of water be selected at
11		this time so that the necessary archeological, environmental and
12		cultural studies can be accomplished with any preservation or
13		
14		mitigation necessary, and the planning, designing, financing and
15		construction can be completed prior to delivery of the water; and
16	WHEREAS,	at a regular meeting of the Schuk Toak District Council on March 16,
17		1985, the District Council discussed the water to be delivered through
18		the Central Arizona Project aqueduct to the District and the selection
19		of land to be serviced by this water; and
20	WHEREAS,	the Schuk Toak District Council discussed two areas, the Garcia Strip
21		and the Vaya Strip, for this agricultural development; and
22	WHEREAS,	the Schuk Toak District Council did pass a resolution selecting and
23		approving lands located in the Garcia Strip for this agricultural

26	NOW. THE	REFORE, BE IT RESOLVED by the Papago Tribal Council that it does hereby
27	1000	approve the use of Tribal lands located in the Garcia Strip, as

Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
