6 of August, 1985, at a meeting at which a quorum was present with a vote of  
7 1640.0 for; -0- against; -0- not voting; and 1 absent, pursuant to the authority  
8 vested in the Papago Council by Article II and Article V, Section 2 (f) of the  
9 Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by  
10 the Papago Tribe on December 12, 1936, and approved by the Secretary of the  
11 Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934  
12 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of  
13 the Interior and is effective as of the date of its enactment by the Papago  
14 Council.
