
1 WHEREAS, The Papago Council did receive and review Six (6) proposals for
2 funding Community Development Block Grant program submitted by the
3 Planning & Research Office on behalf of the applicants;

4 WHEREAS, The Papago Council is satisfied that all necessary and applicable
5 funding requirements have been followed;

6 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby approve and
7 authorize the application/proposals for CDBG funding in accordance with
8 applicable regulations and hereby directs and authorizes Josiah Moore,
9 Chairman, Francisco Jose, Vice-Chairman or Rosita Ruiz, Treasurer to
10 apply for, negotiate and execute any and all contracts, amendments
11 thereto and other documents for implementation of any funding awarded in
12 response to the proposals submitted by the Papago Tribe.


13 The foregoing Resolution was duly enacted by the Papago Council on the 8th
14 day of March, 1985, at a meeting at which a quorum was present with a vote of
15 1440.0 for; -0- against; -0- not voting; and 3 absent, pursuant to the
16 authority vested in the Papago Council by Section 2 (a) of Article V of the
17 Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by
18 the Papago Tribe on December 12, 1936, and approved by the Secretary of the
19 Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934
20 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of
21 the Interior and is effective as of the date of its enactment by the Papago
22 Council.
