WHEREAS, the Presiding Judge of the Papago Tribal Courts, Daniel Lopez, did submit his letter of resignation dated August 15, 1985, to be effective on August 23, 1985; and

WHEREAS, the Law and Order Committee did meet with Daniel Lopez and reviewed his intention of resigning on August 29, 1983 and accepts his resignation thereof.

NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that it does hereby accept the resignation of Presiding Judge, Daniel Lopez, to be effective on August 23, 1985.

The foregoing Resolution was duly enacted by the Papago Council on the 13th day of September, 1985, at a meeting at which a quorum was present with a vote of 1571.0 for; -0- against; 69.0 not voting; and -0- absent, pursuant to the authority vested in the Papago Council by Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
