investigation pending and absolve the three previous Skill Center employees from any criminal allegations so they can be able to find jobs to support their families; and the Tribal Council agrees to provide back pay from the time of their terminations to the date of approval of this resolution with FY 85 tribal funds, and this incident to be removed from their personal records.

The foregoing Resolution was duly enacted by the Papago Council on the 13th day of September, 1985, at a meeting at which a quorum was present with a vote of 790.0 for; 337.5 against; 512.5 not voting and -0- absent, pursuant to the authority vested in the Papago Council by Section  $\overline{2}$  (f) and (h) of Article V of the Constitution and By-Laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
