20 applications are approved, as herein above indicated.


21 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of

25 Ordinance; give notice of this Council's determination in accordance
26 with Section 4 of Article III of the Papago Tribal Enrollment
27 Ordinance; and place the names of each applicant upon the Tribal
28 membership roll in accordance with Article V of the Papago Tribal
29 Enrollment Ordinance.
