WHEREAS, The Enrollment Committee did publish written notice of its recommendation to reject the application and of this hearing, as required by
Section 2, Article IV of the Papago Enrollment Ordinance, amended
by Resolution No. 349-85, and neither the applicant or applicant's
sponsor appeared at this hearing; and

WHEREAS, The Papago Council has reviewed all of the evidence presented and from such evidence finds that the applicant has failed to establish the foregoing membership requirement(s).

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby determine that the application of:
