

1 WHEREAS, An application for enrollment as a member of the Papago Tribe of the
2 the Papago Reservation has been filed by or on behalf of:

8 WHEREAS, The Enrollment Committee has reviewed the application and has recom-
9 mended that the application be denied because the applicant failed
10 to establish the following membership requirement(s): PAPAGO
11 CONSTITUTION & BY-LAWS ARTICLE II MEMBERSHIP - SECTION (1A) & (1B);
12 and
13 WHEREAS, The application has come on for hearing before this Council; and
14 WHEREAS, The Enrollment Committee did serve written notice of its recommen-
15 dation to reject the application and of this hearing, as required by
16 Section 2, Article VI of the Papago Enrollment Ordinance, upon the
17 person who filed the application and such person was/was not present
18 at this hearing; and
19 WHEREAS, The Papago Council has reviewed all of the evidence presented and
20 from such evidence finds that the applicant has failed to establish
21 the foregoing membership requirement(s).
22 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
23 determine that the application of:
24 MICHAEL R. TERRY
25 for enrollment as a member of the Papago Tribe is hereby rejected.

27 BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a
28 certificate of Final Determination of Rejection and that the Enroll-
29 ment Committee serve Notice of Rejection of the application in
30 accordance with the provisions of Section 1 and 2, Article VIII of
31 of the Papago Enrollment Ordinance.

Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
