

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Appointing Commissioner of Papago Housing Authority)


1 WHEREAS, The Ordinance establishing the Papago Housing Authority provides that
2 its affairs be managed by a Board of Commissioners composed of five
3 (5) persons appointed by the Papago Council for staggered terms of
4 four years; and

5 WHEREAS, The four (4) year term of Melissa Norris expired on December 18, 1984,
6 and it is necessary to appoint another person to succede her.

7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that Angelo Joaquin Jr.
8 is hereby appointed to the Board of Commissioners of the Papago
9 Housing Authority for a four (4) year term expiring September 17,
10 1989.


12 The foregoing Resolution was duly enacted by the Papago Council on the 17th
13 day of September, 1985, at a meeting at which a quorum was present with a
14 vote of 1453.0 for; -0- against; 187.0 not voting; and 03 absent, pursuant
15 to the authority vested in the Papago Council by Section 2(e) and (f) of
16 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
17 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
18 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
19 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
20 review by the Secretary of the Interior and is effective as of the date of
21 its enactment by the Papago Council.
