5	ations), did by letter dated August 26, 1985, recommend that the						
6 7	titles of the chief executive officers of the Tohono O'odham Nation						
8	be changed from "Chairman" and "Vice-Chairman" so as to obviate						
9	confusion.						
10	NOW, THEREFORE, BE IT RESOLVED that all references to the proposed Constitution						
11	to "Chairman" and "Vice-Chairman" be changed to "Governor" and						
12	"Lieutenant Governor."						
13	The foregoing Resolution was duly enacted by the Papago Council on the 18th						
14 15	day of September, 1985, at a meeting at which a quorum was present with a vote of 509.0 for; 977.0 against; 153.5 not voting; and 01 absent, pursuant to the authority vested in the Papago Council by Section 2 (e) and (f) of Article V and Article IX of the Constitution and By-laws of the Papago Tribe of Arizona
