The Indian Housing Authority will proceed with the project as acquisition of existing housing or rehabilitation as required by S 6 (h) of the Act, if the Field Office determines as a result of HUD review of the submitted cost comparison (or insufficeint existing housing) documentation that rehabilitation or acquisition of existing housing would cost less than new construction (or that sufficient existing housing is available).

Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
