

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Appointment to PTUA Board)

RES. NO. 77-85

1 WHEREAS, The Plan of Operation of the Papago Tribal Utility Authority (PTUA)
2 provides that the Papago Council shall appoint the directors of the
3 Management Board of the PTUA, and four of such members must have not
4 less than ten years management experience in the utility or related
5 business; and


6 WHEREAS, Mr. Lew Ormsby who filled one of the above positions on the Board, by
7 letter dated February 4, 1985 resigned his position; and

8 WHEREAS, the PTUA Board has unanimously recommended the appointment of Mr.
9 Johnnie R. Raley to fulfill the unexpired term vacated by Mr. Ormsby.

10 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does appoint
11 Mr. Raley to fulfill the unexpired term ending June 30, 1986.

12 The foregoing Resolution was duly enacted by the Papago Council on the 11th
13 day of March at a meeting at which a quorum was present with a vote of 1440.0
14 for; 0 against; 0 not voting; and 1 absent, pursuant to the authority
15 vested in the Papago Council by Section 2 (e) (f) of Article V of the Constitu-
16 tion and By-laws of the Papago Tribe of Arizona as amended, ratified by the
Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior
on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984). Said Resolution is not subject to review by the Secretary of the Interior
and is effective as of the date of its enactment by the Papago Council.
