

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Base Roll Additions)

RES. NO. 781-85

1 WHEREAS, Section 1 (a) of Article II of the Constitution of the Papago Tribe as
2 amended, provides that the Papago Council can make additions and
3 changes to the official census rolls of the Sells and Gila Bend
4 Reservations dated January 1, 1937, and of the San Xavier Reservation
5 dated January 1, 1940, subject to the approval of the Secretary of the
6 Interior; and

8 WHEREAS, the Enrollment Committee has determined that the following named
9 persons were members of the Papago Tribe on the date of the respective
10 census rolls but that their names had been inadvertently omitted
11 therefrom, and had recommended that their names be added to the rolls;
12 and

14 WHEREAS, the Papago Council has reviewed the recommendations of the Enrollment
15 Committee and approves thereof.

16 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that, subject to the
17 approval of the Secretary of the Interior, the names of the following
18 persons be added to the official census rolls of the Sells, Gila Bend
19 or San Xavier Reservation, to wit:



24 of the Interior before their names be formally added to such rolls.


25 The foregoing Resolution was duly enacted by the Papago Council on the 9th day
26 of October, 1985, at a meeting at which a quorum was present with a vote of
27 1581.5 for; -0- against; 58.5 not voting; and 01 absent, pursuant to the
28 authority vested in the Papago Council by Section 1 (a) of Article II and
29 Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe
30 of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
31 approved by the Secretary of the Interior on January 6, 1937, pursuant to
32 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not
subject to review by the Secretary of the Interior and is effective as of the
date of its enactment by the Papago Council.
