
14 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
15 named applicants are eligible for enrollment as members of the
16 Papago Tribe under Section 1 (a) or (b) of Article II of the
17 Papago Constitution and By-laws, as amended, and that their
18 applications are approved, as herein above indicated.

19 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
20 the Papago Tribe reduce this final determination in writing regarding
21 each of the foregoing applications for enrollment in accordance with
22 Section 3 (c) of Article III of the Papago Tribal Enrollment
23 Ordinance; give notice of this Council's determination in accordance
24 with Section 4 of Article III of the Papago Tribal Enrollment
25 Ordinance; and place the names of each applicant upon the Tribal
26 membership roll in accordance with Article V of the Papago Tribal
27 Enrollment Ordinance.

28 The foregoing Resolution was duly enacted by the Papago Council on the 9th day
29 of October, 1985, at a meeting at which a quorum was present with a vote of
30 1453.0 for; -0- against; 187.0 not voting; and 01 absent, pursuant to the
31 authority vested in the Papago Council by Article II and Article V, Section 2
32 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
Secretary of the Interior and is effective as of the date of its enactment by
the Papago Council.


