with Section 4 of Article III of the Papago Tribal Enrollment
Ordinance; and place the names of each applicant upon the Tribal
membership roll in accordance with Aritcle V of the Papago Tribal
Enrollment Ordinance.

The foregoing Resolution was duly enacted by the Papago Council on the 9th day of October, 1985, at a meeting at which a quorum was present with a vote of 1453.0 for; -0- against; 187.0 not voting; and 01 absent, pursuant to the authority vested in the Papago Council by Article II and Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
