


9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby

22 authority vested in the Papago Council by Article II and Article V, Section 2  
23 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,  
24 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
25 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June  
26 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the  
27 Secretary of the Interior and is effective as of the date of its enactment by  
28 the Papago Council.
