

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(San Lucy District Budget FY 1986)

RES. NO. 790-85

1 WHEREAS, The District Council of the San Lucy District did on July 17, 1985
2 by Resolution No. 31-85 approve the attached FY 1986 District Budget
3 in the amount of \$50,464.72; and

4 WHEREAS, The San Lucy District Council did on September 23, 1985 amend District
5 Resolution No. 31-85 to include Council Perdiem & Mileage in the
6 amount of \$4,603.20, and a Loan Payment in the amount of \$7,621.32,
7 increasing the total district budget amount to \$62,689.24; and


8 WHEREAS, the San Lucy District has sufficient funds in its IIM Account to
9 cover the budget; and

10 WHEREAS, The Papago Council has reviewed the attached budget and approves of
11 same.

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
13 approve the attached FY 1986 budget of the San Lucy District in the
14 amount of \$62,689.24 and authorizes expenditures in accordance
15 therewith.

18 The foregoing Resolution was duly enacted by the Papago Council on the 10th day
19 of October, 1985, at a meeting at which a quorum was present with a vote of
20 973.0 for; 185.5 against; 481.5 not voting; and 02 absent, pursuant to the
21 authority vested in the Papago Council by Section 3 (a) and (h) of Article V of
22 the Constitution and By-laws of the Papago Tribe of Arizona as amended,
23 ratified by the Papago Tribe on December 12, 1936, and approved by the
24 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
25 of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date
26 of its approval by the Superintendent of the Papago Agency and is subject to
27 review by the Secretary of the Interior.
