filed on the 27th day of JUNE, 1977; and

WHEREAS, The Enrollment Committee has reviewed the application and has recommended that the application be denied because the applicant failed to establish the following membership requirement(s): PAPAGO CONSTITUTION & BY-LAWS ARTICLE II MEMBERSHIP - SECTION (1A) & (1B); and

WHEREAS, The application has come on for hearing before this Council; and

WHEREAS, The Enrollment Committee did serve written notice of its recommendation to reject the application and of this hearing, as required by Section 2, Article VI of the Papago Enrollment Ordinance, upon the person who filed the application and such person was/was not present at this hearing; and

WHEREAS, The Papago Council has reviewed all of the evidence presented and from such evidence finds that the applicant has failed to establish the foregoing membership requirement(s).

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby determine that the application of:

DALE M. MILDA


for enrollment as a member of the Papago Tribe is hereby rejected.

The foregoing Resolution was duly enacted by the Papago Council on the 28th day of October, 1985, at a meeting at which a quorum was present with a vote of 1471.0 for; 169.0 against; -0- not voting; and 05 absent; pursuant to the authority vested in the Papago Council by Article II and Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
