1 WHEREAS, An application for enrollment as a member of the Papago Tribe of the
2 the Papago Reservation has been filed by or on behalf of:

3 FRANK L. ROBLES 1655-CK-83
4 ("Applicant") (Namely Application No.)

5 filed on the 1st day of JULY, 1983; and

6 WHEREAS, The Enrollment Committee has reviewed the application and has recom-
7 mended that the application be denied because the applicant failed
8 to establish the following membership requirement(s): PAPAGO
9 CONSTITUTION & BY-LAWS ARTICLE II MEMBERSHIP - SECTION (1A) & (1B);

12 WHEREAS, The application has come on for hearing before this Council; and

13 WHEREAS, The Enrollment Committee did serve written notice of its recommen-
14 dation to reject the application and of this hearing, as required by
15 Section 2, Article VI of the Papago Enrollment Ordinance, upon the
16 person who filed the application and such person was/was not present
17 at this hearing; and

19 WHEREAS, The Papago Council has reviewed all of the evidence presented and
20 from such evidence finds that the applicant has failed to establish
21 the foregoing membership requirement(s).

22 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
23 determine that the application of:

24 FRANK L. ROBLES
25 for enrollment as a member of the Papago Tribe is hereby rejected.

26 BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a
27 certificate of Final Determination of Rejection and that the Enroll-
28 ment Committee serve Notice of Rejection of the application in
29 accordance with the provisions of Section 1 and 2, Article VIII of
30 of the Papago Enrollment Ordinance.

1 The foregoing Resolution was duly enacted by the Papago Council on the 28th day
2 of October, 1985, at a meeting at which a quorum was present with a vote of
3 1640.0 for; -0- against; -0- not voting; and 05 absent; pursuant to the
4 authority vested in the Papago Council by Article II and Section 2 (f) of
5 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
6 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
7 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
8 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
9 review by the Secretary of the Interior and is effective as of the date of
10 its enactment by the Papago Council.
