WHEREAS, The application has come on for hearing before this Council; and WHEREAS, The Enrollment Committee did serve written notice of its recommendation to reject the application and of this hearing, as required by Section 2, Article VI of the Papago Enrollment Ordinance, upon the person who filed the application and such person was/was not present at this hearing; and

WHEREAS, The Papago Council has reviewed all of the evidence presented and from such evidence finds that the applicant has failed to establish the foregoing membership requirement(s).

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby determine that the application of:

ESPERANZA G. GARCIA

for enrollment as a member of the Papago Tribe is hereby rejected.

BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve Notice of Rejection of the application in accordance with the provisions of Section 1 and 2, Article VIII of of the Papago Enrollment Ordinance.

Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
