

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Adoption into Tribal Membership)

RES. NO. 828-85

1 WHEREAS, CHOGYUHA, Theresa A., ESCARSEGA, Mael, ESCARSEGA, Mike J., ESCARSEGA
2 Ramona, SALAZAR, Juanite V. have made application for adoption into
3 Tribal membership pursuant to Section 2 of Article II of the Consti-
4 tution of the Papago Tribe; and

5 WHEREAS, the Enrollment Committee has reviewed their respective applications,
6 had made a final determination that they are 1-1/2 degree or more of
7 Papago Indian blood, and have made a recommendation to the Papago
8 Council that their applications be approved, all in accordance with
9 the provisions with the Papago Enrollment Ordinance; and

10 WHEREAS, the Papago Council has reviewed the recommendation of the Enrollment
11 Committee and the evidence submitted in support of the individual
12 applications.



20 Papago Tribe.

21 The foregoing Resolution was duly enacted by the Papago Council on the 28th day
22 of October, 1985, at a meeting at which a quorum was present with a vote of
23 1,271.0 for; -0- against; 128.0 not voting; and 241.0 absent, pursuant to the
24 authority vested in the Papago Council by Article II and Article V, Section 2
25 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
26 ratified by the Papago Tribe on December 12, 1936, and approved by the Secre-
27 tary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
Secretary of the Interior and is effective as of the date of its enactment by
the Papago Council.
