

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(ENROLLMENT - October)


21 NOW, THEREFORE BE IT RESOLVED that it is hereby determined that the above
22 named applicants are eligible for enrollment as members of the
23 Papago Tribe under Section 1 (a) or (b) of Article II of the
24 Papago Constitution and By-laws, as amended, and that their
25 applications are approved, as herein above indicated.

27 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
28 the Papago Tribe reduce this final determination in writing regarding
29 each of the foregoing applications for enrollment in accordance with
30 Section 3 (c) of Article III of the Papago Tribal Enrollment
31 Ordinance; give notice of this Council's determination in accordance

1 with Section 4 of Article III of the Papago Tribal Enrollment
2 Ordinance; and place the names of each applicant upon the Tribal
3 membership roll in accordance with Article V of the Papago Tribal
4 Enrollment Ordinance.

6 The foregoing Resolution was duly enacted by the Papago Council on the 28th
7 day of October, 1985, at a meeting at which a quorum was present with a vote
8 of 1399.0 for; -0- against; -0- not voting; and 241.0 absent, pursuant to the
9 authority vested in the Papago Council by Article II and Article V, Section 2
10 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
11 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
12 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of
13 June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
14 Secretary of the Interior and is effective as of the date of its enactment by
15 the Papago Council.
