

25 day of October, 1985, at a meeting at which a quorum was present with a vote  
26 of 1376.0 for; 42.5 against; 221.5 not voting; and 04 absent, pursuant to the  
27 authority vested in the Papago Council by Article II and Article V, Section 2  
28 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,  
29 ratified by the Papago Tribe on December 12, 1936, and approved by the Secre-  
30 tary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of  
31 June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the  
32 Secretary of the Interior and is effective as of the date of its enactment by  
the Papago Council.
