

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Suspending Franklin Antone)



1 WHEREAS, The Papago Council has been advised that Franklin Antone, Chief Judge
2 of the Papago Tribal Courts, has been arrested for driving while
3 intoxicated and is awaiting trial on the charge, and that the Chairman
4 of the Papago Tribe, believing that it is incumbent on a person
5 holding judicial office to comport him or herself in a manner that
6 will not adversely reflect on the dignity and indignity of the office,
7 did suspend Franklin Antone without pay as Chief Judge for an indefi-
8 nite period, pending disposition of the charge.



10 NOW, THEREFORE BE IT RESOLVED by the Papago Council that it concurs in and
11 ratifies the action of the Chairman that Franklin Antone be and is
12 hereby suspended without pay as Chief Judge of the Papago Tribal
13 Courts for an indefinite period, pending the disposition of the
14 criminal charge brought against him.

16 The foregoing Resolution was duly enacted by the Papago Council on the 28th
17 day of October, 1985, at a meeting at which a quorum was present with a vote
18 of 1,390.0 for; 191.5 against; 58.5 not voting; and 04 absent, pursuant to the
19 authority vested in the Papago Council by Section 2 (e) and (f) of Article V of
20 the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified
21 by the Papago Tribe on December 12, 1936, and approved by the Secretary of the
22 Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934
(48 Stat. 984). Said Resolution is not subject to review by the Secretary of
the Interior and is effective as of the date of its enactment by the Papago
Council.
